ORDER

The 19th September 2011

No. 4161—Ele.(GP)-75/2011-SEC.—Whereas, State Election Commission had issued Schedule for preparation and printing of Wardwise Electoral Rolls of all Grama Panchayats for conduct of the General Elections to the 3-tiers of Panchayati Raj Institutions vide Commission's Order No. 3306, dated the 12th August 2011;

Whereas, Schedule issued on the 12th August 2011 was postponed by the State Election Commission due to heavy flood situation in some districts vide Commission's Order No. 3665, dated the 13th September 2011;

Now, therefore, the State Election Commission, in exercise of powers vested in it by virtue of Article 243-K of the Constitution of India, read with relevant provisions of Orissa Grama Panchayat Act, 1964, Orissa Panchayat Samiti Act, 1959 and Orissa. Zilla Parishad Act, 1991 and Rules framed thereunder directs that Wardwise Preliminary Electoral Roll of all Grama Panchayats shall be prepared as per the Schedule given below. All other procedures communicated earlier vide Commission's Orders No. 3306, dated the 12th August 2010 remain unchanged.
