NOTIFICATION

The 1st October, 2011

S.R.O. No. 915/2011—The following draft of certain rules which the State Government propose to make in exercise of the powers conferred by Section 656 of the Orissa Municipal Corporation Act, 2003 (Orissa Act 11 of 2003) is hereby published as required by sub-section 1 thereof for information of all persons likely to be affected thereby and the notice is hereby given that the said draft will be taken into consideration by the State Government on or after the expiry of a period of fifteen days from the date of publication of this notification in the official gazette.

Any objection or suggestion which may be received from any person in respect of the said draft before the expiry of the period so specified will be taken into consideration by the State Government.

Draft

1. (1) These rules may be called the Orissa Municipal Corporation (Amendment) Rules, 2011.

(2) They shall come into force on the date of their publication in the Orissa Gazette.

2. In the Orissa Municipal Corporation Rules, 2004 (hereinafter referred to as the said Rules), for rule 17, the following rule shall be substituted, namely:—

“17. Appointment of Officers by the Government –

In each Corporation, the posts mentioned in column(2) of Schedule ‘A’ shall be filled up by Government from the Officers of the cadre specified in column(3) thereof in such number as may be decided by them from time to time.”

3. In the said Rules, for Schedule ‘A’, the following Schedule shall be substituted, namely:—

5	Secretary -cum-OSD to Mayor.	By deputation from OAS(Group-A, JB)
6	Deputy Secretary	By deputation from Government / Corporation services

9	Chief Finance Officer	By deputation from OFS
10	City Health Officer	By deputation from Health & Family Welfare Department not below the rank of Deputy Director, Orissa Medical and Health services.
11	Assistant Health Officer (Sanitation Drainage and Sewerage).	By deputation from Health & Family Welfare Department Medical Officer not below the rank of Assistant Surgeon / from H. & U.D. Department not below the rank of Assistant Engineer.
12	Assistant Health Officer (TB, Malaria, Filariasis, Epidemics, etc.)	By deputation from Health and Family Welfare Department Medical Officer not below the rank of Assistant Surgeon.
13	Sanitary Inspector	By deputation from Government /Corporation services
14	City Engineer	By deputation from Housing & Urban Development Department not below the rank of Superintending Engineer (Public Health).
15	Executive Engineer	By deputation from Housing & Urban Development Department (PHED) / Water Resources Department in the rank of Executive Engineer.
16	Assistant Executive Engineer (Civil).	The post shall be filled up by promotion from among the post of Assistant Engineer (Civil) of Corporation or by deputation.
17	Assistant Engineer (Civil)	Two third of the posts shall be filled up by deputation from line Departments of Government and Corporations and one third of posts shall be filled up by way of selection and promotion from amongst the LFS(JE).

18	Assistant Engineer (Mechanical)	By deputation from Government / Corporation Services
19	Assistant Engineer (Electrical)	By deputation from Government in the Department of Energy/Corporation Services.

22	Junior Engineer (Electrical)	By deputation from Government / Corporation Services
23	Environment Officer	By deputation of an officer from Forest & Environment Department.

25	Judicial Magistrate	By deputation from Orissa Judicial Services in the rank of SDJM or as decided by Government.
26	Public Relation Officer	To be recruited by the Corporation.
27	Asst. Law Officer	To be filled up from LFS Cadre.
28	Other Officers as required by the Corporation.	As decided by Government from time to time
