AWARD

The Government of Orissa in the Labour & Employment Department in exercise of the powers conferred upon them by sub-section (5) of Section 12, read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 1477—li-1(B)-103/2001-LE., dated the 5th February 2002 :—

“Whether the termination of employment of Shri Dullar Ku. Rout, Shri Manoj Ku. Rout, Shri Debendra Bhoi, Shri Laxmidhar Nayak, Shri Kusha Behera, Shri Jagabandhu Jena, and Shri Arun Kumar Bhoi by the management of M/s Ram’s Assorted Cold Storage Ltd., Pratapnagari, Telengapentha, Cuttack with effect from the 20th February 2001 is legal and/or justified ? If not to what relief the above named workman are entitled ?”.

2. The workman is absent. No steps taken. On perusal of the case record I found that the workman neither present in the Court nor filed his claim statement till yet, which amounts that he was not interested to proceed with the case. I also found no reasonable ground to adjourn the case further more as sufficient opportunities given to him. Hence in absence of claim statement and evidence on record a no Award possible is passed accordingly.
