AWARD

This case arises out of the reference made by the Government of Odisha, Labour & Employment Department conferred by sub-section (5) of Section 12 read with Clause (c) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) vide memo No. 4027(5), Dtd. 26-4-2011 for adjudication of the dispute in the Schedule :

“Whether the termination of services of Shri Prafulla Kumar Tripathy, Accountant with effect from Dt. 17-3-2006 by the Management of M/s D. V. Steel Industries (P) Ltd., Kacheri Road, Rourkela is legal and/or justified ? If not, what relief Shri Tripathy is entitled to ?”

The Second party workman neither filed his statement of claim nor took any step in the Court as per order of the State Government, Labour & Employment Department contained in the reference and also on issue of repeated notices from the Court. As it appears that the workman is not interested to proceed with the present case. Hence I do hereby pass a ‘No Dispute Award’ so far as the present reference is concerned.
