No. 14999—V-SI-(Vol.-II)-44/2011-I.—In pursuance of Law Department Notification No. 1195-I.-Legis/31-10/L of the 25th January, 2011 under the Orissa Saw Mills and Saw Pits (Control) Amendment Act, 2010, the following existing Notified Industrial Estates/Areas/ Growth Centre under the Management of IDCO are hereby declared as Industrial Estates/Areas under Clause (i) of Section 2 of the IDCO Act, 1980 for the purpose of rehabilitation of the de-licensed Saw Mills in Odisha as per order of the Hon'ble Supreme Court of India vide their order, dated the 16th August 2010 in I. A. No.1579/1580 in W.P.(C) No. 202/1995/W.P.(C) No. 356/2007 to rehabilitate the eligible identified Saw Mills in Odisha.
