No. 1053/2011—Whereas, the Government of Odisha in the Panchayati Raj Department have, by order under Section 12 of the Orissa Grama Panchayat Act, 1964 published in the Official Gazette on the 23rd December 2011 called upon all the Grama Panchayats except Dhinkia Grama Panchayat under Ersama Block in Jagatsinghpur District in the State to elect Ward Members and Sarpanches for the purpose of constituting the Grama Panchayats ;

Whereas, as per the orders of the Hon'ble High Court elections to the office of Sarpanch of Talabarkote and Sankarpur Grama Panchayat under Dhenkanal Sadar Block in Dhenkanal District, Krushnachhai Grama Panchayat under Sheragada Block and Kanchana Grama Panchayat under Khallikote Block in Ganjam District, Kurijanga and Lataharan Grama Panchayat under Kakatpur Block in Puri District and Bankipali Grama Panchayat under Dunguripalli Block in Subarnapur District are not being notified ;
