S.R.O. No. 1064/2011— In pursuance of Section 6 of the Unorganized Workers Social Security Act, 2008 (No.33 of 2008), the State Government do hereby constitute the Odisha State Social Security Board for welfare of the Unorganized Workers of the State with the following members to exercise the powers conferred on and to perform the functions assigned to it under the provisions of the Act and the term of which shall be of three years, namely:—
