### NOTIFICATION

The 8th April, 2011

**S.R.O. No.268/2011**—In pursuance of sub-section (1) and clause(h) of sub-section(2) of Section 54 of the Orissa Municipal Act,1950(Orissa Act 23 of 1950), the State Government do hereby publish the following resolution passed by two third of the total number of the councillors of Balugaon, Notified Area Council at a meeting of the said council held at 11.30 A.M. on the 22nd March, 2011 in the Conference Hall of the Balugaon, Notified Area Council specially convened by the Collector & District Magistrate, Khurda and presided over by the Sub-Collector, Khurda having been specially authorized by the Collector & District Magistrate, Khurda under clause (d) of sub-section (2) of Section 54 of the said Act, recording want of confidence in Sri Maheswar Palai, Chairperson of the aforesaid council along with records of proceedings at such meeting.

As such Sri Maheswar Palai holding the office of Chairperson of the Balugaon Notified Area Council shall be deemed to have vacated such office with effect from the date of passing of the resolution i.e. the 22nd March, 2011.

Proceeding of no confidence Motion meeting against Chairman N.A.C. Balugaon held on 22.3.2011 at 11.30 A.M. in the conference Hall of N.A.C. Balugaon.

As per the direction of Collector, Khordha communicated vide Dist. Office Memo No.499, dt.14.3.2011 service of Notice along with copy of Resolution & requisition was served among the councillors. On the scheduled day of meeting of no confidence out of 11 councillors, 10 councillors remained present and participated in the motion of no confidence. The meeting was presided over by the undersigned Sri Gangadhar Sahoo O.A.S., Sub-Collector, Khordha being nominated by District Magistrate, Khordha.

The Presiding officer welcomed all the members present to the motion of no confidence. The members were invited for a discussion on the single Agenda on no confidence Motion cited in the Resolution dt.8.3.2011.

Two members Sri Satya Narayan Senapati & Sri Golak Behera talked on the resolution and motion of no confidence. Thereafter secret voting took place. 10 (ten) members out of 10 (ten) present exercised their franchise. One member while exercising his franchise displayed his ballot paper which was objected and cancelled. At last the sealed Box was opened and votes were counted. It was found that 8 (eight) Councillors voted in favour no confidence one voted against the no confidence. One vote was rejected for violation of secrecy.

As per the provision of Municipal Manual, 1950 proceeding need to be sent to Government under intimation to District Magistrate, Khordha for needful action at their end. The meeting ended with vote of thanks.
