ORDER

No. 6302-SEC.—Whereas, it is reported by the Executive Officer, Sambalpur Municipality that casual vacancy in the Office of Chairperson of Sambalpur Municipality has occurred due to no-confidence motion moved against Chairperson through Sambalpur Municipality Council Resolution on the 7th May 2012;

Whereas, the Government in H & UD Department vide Notification No. 15257, dated the 29th May 2012 have published the said Council Resolution;

Whereas, it is necessary to conduct by-election to fill up the said casual vacancy;

Now, therefore, in exercise of powers conferred under Section 49 of The Odisha Municipal Act, 1950 and Rule 68 of The Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994, the State Election Commission appoints following dates for holding of election to fill up the aforesaid casual vacancy.
