## A W A R D

The present dispute arose out of the reference made by the Government of Odisha, Labour & Employment Department, vide their Order, dated the 16th March 2011 under Letter No. 2524— I D-15/2011-LE., giving rise to the registration of the present case under Sections 10 and 12 of the Industrial Disputes Act, 1947 (for short, the “Act”). The dispute involved is scheduled as follows :

“Whether the action of the Management of M/s Hirakud Industrial Works Ltd., Hirakud, Dist. Sambalpur in declaring suspension of work/operation of the factory with effect from 8 P.M. of 01-12-2007 is legal and/or justified ? If not, to what relief the workmen are entitled ?”

2. On repeated notices sent to the General Secretary of Hirakud Industrial Works Workers Union, none appeared before this Court to file the statement of claim nor any intimation received from him even by post. As it appears that the workmen and the Union are not interested to proceed with the present case. Hence, I, do hereby pass a “No Dispute Award” so far as the present reference is concerned.
