### NOTIFICATION

The 24th August 2012

No. 23991—TPD-(OSD)-42/2012-HUD.—In exercise of the powers conferred under sub-section (1) of Section 7, read with Sections 8, 11 & 13 of the Odisha Town Planning & Improvement Trust Act, 1956 (Odisha Act 10 of 1957), the State Government do hereby direct that consequent upon expiry of the term of the Trust Board of Balasore Regional Improvement Trust with effect from the 17th June 2012 constituted in H. & U.D. Department Notification No. 12959-HUD., Dt.22-5-2009 published in *Odisha Gazette* vide Notification No. 781, Dt. 18-6-2009, the Trust Board of the said Improvement Trust shall now consist of the following members. The term of the Trust Board (other than *Ex officio* Trustees) shall be for a period of three years with effect from the date of publication of the Notification in the *Odisha Gazette* or until further orders of Government whichever is earlier.
