S.R.O. No.545/2012— Whereas, it has been brought to the notice of the State Government that Shri Subash Chandra Mishra, Chairperson of Banki N.A.C. has acted in gross violation of the provisions of Odisha Municipal Act, 1950 and the rules made there under.

And, whereas, the Chairperson has constituted different committees, for supervision of developmental work as per his own sweet will, executed development works through his followers, involved himself in purchase of sub-standard electrical materials and committed many irregularities;

Now, therefore, in exercise of the powers conferred by sub-section (1) of Section 53 of the Odisha Municipal Act, 1950 (Odisha Act 23 of 1950), the State Government do hereby direct the District Magistrate, Cuttack to enquire into the aforesaid allegations (copy enclosed) and furnish report within a fortnight.

Statement of IMPUTATION against the Chairperson of Banki NAC

1. The Chairperson has constituted different committees for supervision of developmental work as per his own sweet will without making election and adopting procedure for constitution of committees.
2. The proceedings of the council meetings are not being informed to the concerned Collector as well as to Government within the stipulated period i.e. 3 days from the setting of the council.
3. During the year, 2009, some decisions were taken for execution of work to mitigate the heat wave conditions. Due to imposition of model code of conduct for Assembly Election, that programme could not be carried out and the Chairperson executed the same work through his followers on back date.
4. In the council meeting on 30th May, 2009, decision was taken to purchase electrical items to the tune of ₹ 8—11 lakhs for the year, 2009-10 on the basis of open tender process. But the Chairperson as per own sweet will purchased some substandard electrical items at higher rate.
5. The Chairperson has misappropriated 60% of the fund by installing substandard local fittings in the premises of Maa Charchika Temple.
6. In the Council Meeting, it was decided to purchase Hydraulic trolley to carry out garbage as there is less man power in the N.A.C. But the Chairperson without giving due importance to the Council decision, purchase Jindal Tractor having manual Trolley which is not sufficient to lift the garbage.
7. The Chairperson is involved in low quality cess pool purchase.
8. The Chairperson has received T.A. by producing false T.A. Bills.
9. During the last flood an amount of ₹ 3.40 cores was sanctioned for construction of flood affected N.A.C. roads. That fund has been utilized for repair of Roads with huge Kickback and the quality of work was very poor.
