Now, therefore, the State Election Commission in exercise of powers conferred under Article 243K of Constitution of India and such other enabling powers under Panchayat Samiti Election Laws is pleased to order that fresh election in respect of the office of Panchayat Samiti Member where election was countermanded shall be held as per the following Programme :—

N. B. 1. The Model Code of Conduct will remain in force from the 23rd March 2012 to the 9th May 2012 in the concerned Samiti Constituency.

The nomination of contesting candidates except the deceased whose names have been published under Rule 11(6) on the previous occasion i. e., on the 18th January 2012 during last General Election to P.R.Is., 2012 shall remain valid. They shall not file nominations again and they shall be intimated about the election schedule.
3. Withdrawal of candidature is only permissible for those candidates who are going to file nomination during this period.
4. Allotment of symbol shall be done afresh in Odia alphabetical order.
