ORDER

No. 111-SEC.—Whereas, it is reported by the Executive Officer, Joda Municipality that casual vacancy in the office of Chairperson of Joda Municipality has occurred due to no-confidence motion moved against Chairperson through Joda Municipality Council Resolution on 24-9-2011;

Whereas, the Government in Housing & Urban Development Department vide Notification No. 34958, Dt. 17-12-2011 have published the said Council Resolution;

Whereas, it is necessary to conduct by-election to fill up the said casual vacancy;

Now, therefore, in exercise of powers conferred under Section 49 of the Odisha Municipal Act, 1950 and Rule 68 of The Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994, the State Election Commission appoints following dates for holding of election to fill up the aforesaid casual vacancy :—
