NOTIFICATION

The 3rd April, 2012

S.R.O. No.139/2012— Whereas having regard to the population of area consisting of villages in the District of Bhadrak mentioned in Column (2) of the Schedule below, the density of the population therein, the revenue generated for local administration, the percentage of employment in non-agricultural activities and the economic importance of the said area, it has been considered necessary to specify the said area as 'transitional area' ;

And whereas, draft notification as required under the proviso to sub-section(2) of Section 4 of the Orissa Municipal Act,1950 specifying the said area as a transitional area was issued inviting objections and suggestions, if any, from all persons likely to be affected there by in the notification of the Government of Odisha in the Housing & Urban Development Department No.15192/HUD., dated the 24th June,2011 ;

And whereas, there is no objection (petition) from any where of the locality received through the District Magistrate, during the stipulated period of six weeks which has already been over ;

Now, therefore, in exercise of the powers conferred by clause (2) of Article 243Q of the Constitution of India read with Section 4 of the Orissa Municipal Act, 1950 (Orissa Act,23 of 1950), the Governor of Odisha do hereby specify the said area as 'transitional area' with effect from the date of publication of this notification in the *Odisha Gazette*.
