### NOTIFICATION

The 8th August, 2013

**S.R.O. No.527/13**— The following proposals which the State Government intend to make in exercise of the powers conferred by Section 27 of the Minimum Wages Act, 1948(11 of 1948) for addition of certain employments in the existing entries, against Serial Nos. 12, 18, 20, 22, 43, 52, 59, 67, 71 and 72 as mentioned below and for addition of the new employments to Part-I of the schedule of the said Act for the whole State of Odisha, is hereby published as required by the said section of the said Act for information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration on expiry of a period of three months from the date of publication of this notification in the *Odisha Gazette*.

Any objection or suggestion which may be received from any person in respect of the said proposals before' expiry of the period specified above will be considered by the State Government.

### SCHEDULE DRAFT

1. Addition of employments to the existing entries in the Schedule:—
  1. In Serial Number 12, after the words "Cinema Industry" the comma and words, "Film Production" shall be added;
  2. In Serial Number 18, after the words "Contingent and Casual employees in Government and other establishment," the comma and words, "Private Courier and Cargo Services" shall be added;
  3. In Serial Number 20, after the words "Dispensary of Medical Practitioners in any establishment of medical consultant or in any Chemical or Pathological Laboratory," the comma and words, "Private Nursing Homes, Private Medical College Hospitals, Super Specialty Hospitals, Clinic, Laboratory" shall be added;
  4. In Serial Number 22, after the words "Electricity Board", the comma and words, "Electricity Transmission, Generation and Distribution" shall be added;

5. In Serial Number 43, after the words "Manufacturing of Electrical Bulbs", the comma and words, "Manufacturing of all Allied Electrical Equipments" shall be added;
6. In Serial Number 52, for the words "Minor Engineering Industry", the words and commas, "Major and Minor Engineering Industry including Sponge, Secondary Steel, Rolling Mills and Ferroalloys Metals Industries" shall be added;
7. In Serial Number 59, after the words "Printing Press," the comma and words, "DTP Centre and Offset Printing Press" shall be added;
8. In Serial Number 67, after the words "Rice Mill, Floor Mill and Dal Mill" the comma and words, "Chuda Mill and Masala Mill" shall be added;
9. In Serial Number 71, in place of the words "Shops and Establishment", the words and comma, "Shops and Commercial Establishments, Saloon, Beauty Parlour, Spa, Massaging Centre, Xerox Shop, STD Booth, Tent House, Newspaper Hawkers and Newspaper Establishment" shall be proposed to be added;
10. In Serial Number 72, after the words "Siali Leaf Pluckers," the comma and words" Sal Leaf Pluckers" shall be added.

**2. New Employments to be added to the Schedule:—**

In the Schedule of Employment, after Serial No.84, the following employments with corresponding Serial Numbers shall be added, namely:—
