ORDER

The 30th January 2013

No. 555—ML-37/2013-SEC.—Whereas, it is reported by the Executive Officer, Municipality, Rajgangpur that casual vacancy in the Office of Chairperson of Municipality, Rajgangpur has occurred due to no-confidence motion passed against Chairperson on the 6th October 2012;

Whereas, the Government in H. & U.D. Department, Odisha have published the said resolution in *Odisha Gazette* on the 9th January 2013;

Whereas, it is necessary to conduct by-election to fill up the said casual vacancy;

Now, therefore, in exercise of powers conferred under Section 49 of The Odisha Municipal Act, 1950 and Rule 68 of The Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 and in pursuance to order passed by Hon'ble High Court of Odisha in Writ Petition (C) No. 18682 of 2012 the State Election Commission appoints the following dates for holding of election to fill up the aforesaid casual vacancy:—
