2. The SPV will be incorporated as Joint Venture of the Berhampur Development Authority (BeDA), Berhampur Municipal Corporation (BeMC), Odisha State Road Transport Corporation (OSRTC), Chhatrapur NAC, Gopalpur NAC, and Hinjilicut NAC.

3. The registered Office of the SPV "Ganjam Urban Transport Service Limited (GUTSL)" shall be at the BeDA Office at Berhampur in the district of Ganjam, Odisha.

4. The objective/ role/ charters of the SPV are as under:

- (a) To provide safe, affordable, comfortable, reliable and sustainable transport service for the growing number of urban residents in Ganjam Districts.
- (b) To plan, establish, regulate, monitor the operations of City Bus Service.
- (c) To achieve a high level operational efficiency
- (d) To attain financial self-sufficiency
- (e) To purchase, charter, hire, acquire buses for public transport purpose as also to dispose of any such buses.
- (f) To purchase, construct, sell, develop, take in exchange or on lease, hire or otherwise acquire any assets/ estate to develop infrastructure required for efficient operation of the City Bus Service.
- (g) To raise finances, through innovative mechanisms for investments in urban transport infrastructure.
- (h) To associate the private sector in activities where their strengths can be beneficially tapped.
- (i) To promote the use of cleaner technologies.
- (j) To reduce pollution levels through changes in travelling practices, better enforcement, stricter norms, technological improvements etc.

5. The following persons/ entities shall be the subscribers to the Memorandum and Articles of Association of the SPV.
