No. 7175—(ML) 42/2013-SEC.—Whereas, the date of election to the office of Vice-Chairperson of Athamalik NAC and Jeypore Municipality was fixed on the 22nd October 2013 ;

Whereas, election to the office of Vice-Chairperson of Athamalik NAC could not be held due to no nomination by the candidates and Jeypore Municipality due to withdrawal of all candidatures during Poll.
