The 31st October, 2013

No. 31732-HUD-13-REFM-65-SCH-17-0122/2013/HUD.— Government of Odisha have decided to set up a Trust namely “Odisha Urban Transport Fund (OUTF)” in the Housing & Urban Development Department for the purpose of achieving sustainable Urban Transport System in the State with the following Members.

The above Trustees shall be collectively called Board of Trustees who would manage and administer the affairs of the Trust and Trust Funds.

2. The objectives of the Trust are—

- to achieve Sustainable Urban Transport System in the State;
- to mobilise additional resources for sustainability Urban Transport framed in the State;
- to administer the fund for promotion of urban transport in general and public transport and non-motorized transport in specific through Urban Local Bodies (ULBs) and Special Purpose Vehicles (SPVs) in Odisha;

- (d) to provide financial assistance to Urban Local Bodies and Special Purpose Vehicles for development of urban transport infrastructure such as cycle tracks, cycle stands, terminals, depots, bays, corridors etc;
 - (e) to provide grant to Urban Local Bodies and Special Purpose Vehicles for acquisition of para transit, cycles, bus fleets;
 - (f) to ring fence public transport fare by means of fare compensation to SPVs and or ULBs as interim and/or long term basis;
 - (g) to identify problems and take up research and development studies for providing support to public transport;
 - (h) to promote international cooperation, in particular, technical assistance and/or with financial assistance which may promote the urban transport and non-motorized transport sector in the state as also human resources through Government of India and other Countries; and
 - (i) to provide low interest or interest free loans and grants for activities related to any of the aforesaid objects.
- 3.** The assets of the fund shall include:
- (1) Accruals from;-
 - (a) Additional Registration Fees on vehicles registered in Urban Areas
 - (b) Stamp Duty
 - (c) Any other source to be notified by the State Government.
 - (2) In addition to the accruals from sources mentioned above, the assets shall include Rupees 3 crore to be provided out of the Plan Budget of the Housing & Urban Development Department, Government of Odisha as seed capital.
- 4.** The Trust shall come into existence from the date of publication of the Notification.
