RESOLUTION

The 5th July, 2014

Sub: Transfer of the left out Lower Secondary (ME) and Secondary Schools of Urban Local Bodies to the control of School & Mass Education Department.

It has been decided that, education as an administrative activity is no longer remain within the domain of Housing & Urban Development Department. In conformity with the above decision in the past 72 left out Primary Schools, 65 Lower Secondary (ME) Schools and 82 Secondary Schools of the Urban Local Bodies were transferred to School & Mass Education Department vide Housing & Urban Development Department Resolution No:4942/M-III-M-43/2003/HUD, dated the 28th February, 2004.

2. It was subsequently noticed that some schools managed by some of the Urban Local Bodies were not transferred to School & Mass Education Department during that period. Hence, Government have therefore decided to transfer the following eligible left out ULB schools along with the teaching and non-teaching staff covered under yardstick of School & Mass Education Department to the administrative control of School & Mass Education Department and declared the teaching and non-teaching staff as Government employees With effect from the actual date of transfer.

1. Sanjay Gandhi High School, Malimunda, Jharsuguda Municipality.
2. Municipal Girls High School, Kendrapara, Kendrapara Municipality.
3. NAC Girls High School, Pipili, Pipili NAC.
4. Municipal High School, Balasore, Balasore Municipality.

5. Mukunda M.E. School, Deogarh, Deogarh Municipality.
6. Dharanidhar U.P.(ME) School, Deogarh Municipality.
7. Badabazar Hindi M. E. School, Sambalpur Municipality.

3. Determination of service condition: The determination of service condition of the employees above mentioned schools which are transferred to School & Mass Education Department shall be made in the following manner.

- (i) **Fixation of pay** : The fixation of pay of both Teaching and Non-Teaching Staff will be made by the School & Mass Education Department under rule 74 (d) of Odisha Service Code.
- (ii) **Inter-se-seniority** : Modalities are to be decided by School & Mass Education Department.
- (iii) **Other service condition** - Other service condition such as pension, leave salary, other retirement benefits, G.P.F., H.R.A., Promotion, Transfer and age of superannuation etc. will be applicable to the teaching and non-teaching staff of the above mentioned schools, as applicable to the teaching and non-teaching staff of School & Mass Education Department.

4. Building etc. - The Building, infrastructure including land, building & furniture will be transferred to the control of School & Mass Education Department for maintenance and up-keepment. School & Mass Education Department will not pay the cost of assets to the concerned Urban Local Bodies.

5. No dues/service continuity for the period prior to the actual date of physical transfer of the schools to the School & Mass Education Department will be allowed to the teaching and non-teaching staff of the above mentioned school.

6. School & Mass Education Department will not be liable for any liability relating to the period prior to the actual date to transfer.

7. No dues/service continuity for the period prior to the actual date of physical transfer of the Schools to the School & Mass Education Department will be allowed to the teaching and non-teaching staff of the concerned schools.

8. Any legal complicacy relating to the period prior to the actual date of transfer to School & Mass Education Department shall be the concern of H&UD Department.

9. The teaching and non-teaching staff of the above seven Schools (4 High Schools & 3 M. E. School) shall furnish an undertaking at the time of taken over to the effect that he/she shall be abide by the decisions to be taken in the matter of service conditions, pay scale and *inter-se-seniority* in consultation with Finance and Law Department.

10. This has been concurred in by School & Mass Education Department, vide their UOR No.3/S&ME, dated the 6th June, 2013 and Finance Department vide their UOR NO.284 WF-I, dated 21st November, 2012.

ORDER

Ordered that, the resolution be published in an Extraordinary issue of the *Odisha Gazette* and forwarded to all Departments of Government/all Heads of Departments/all Revenue Divisional Commissioners/all District Magistrates/all Urban Local Bodies.
