NOTIFICATION

The 19th July, 2014

S.R.O. No.320/2014— Whereas, having regard to the population of the area consisting of villages in the District of Kalahandi mentioned in column (2) of the Schedule below, the density of population therein, the revenue generated for local administration, the percentage of employment in non-agricultural activities and the economic importance of the said area, it has been considered necessary to specify the said area as “transitional area”;

And, whereas, draft notification as required under the proviso to sub-section (2) of Section 4 of the Odisha Municipal Act, 1950 specifying the said area as a transitional area was issued inviting objections and suggestions, from all persons likely to be affected thereby in the notification of the Government of Odisha in the Housing & Urban Development Department No. 4051/ HUD., dated the 15th February, 2014;

And, whereas, suggestions have been received from villagers of Talpadar, Srirampur, Bikramguda, Godbhanja and Bagad villages through the District Magistrate, Kalahandi in the stipulated period of time were considered;

Now, therefore, in exercise of the powers conferred by clause (2) of Article 243Q of the Constitution of India read with sub-section(2) of Section 4 of the Odisha Municipal Act, 1950 (Odisha Act, 23 of 1950), the Governor of Odisha do hereby specify the area consisting of villages mentioned in column (2) of the Scheduled below with the description of boundaries as ‘transitional area’ with effect from date of publication of this notification in the *Odisha Gazette*.
