The Government of Odisha in their Labour & Employment Department in exercise of their powers conferred under sub-section (5) of Section 12 read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 have referred the following dispute Vide Order No. 32—li1(SS)-07/949 dated the 30th January, 2008:—

"Whether the Contract Labourers of M/s Odisha Sponge Iron & Steel Ltd., Palasapanga, Keonjhar are entitled for payment of D.A. & V.D.A.? If so, what should be the details?"

2. On notices being sent to both parties, neither they appeared nor took any steps. From this it can be presumed that either they have settled their dispute amicably outside the court or they have no dispute between them. Accordingly No Dispute Award is passed.
