**S.R.O. No. 347/2014**— In pursuance of Section 7 read with section 9 of the Minimum Wages Act, 1948 (11 of 1948) and in supersession of the notification of the Government of Odisha in the erstwhile Labour & Employment Department, No. LL-7198-I-(AR)1/11/LE., dated the 8th August, 2011, the State Government do hereby appoint an Advisory Board consisting of the following persons for the purpose of co-ordinating the work of the committees and sub-committees appointed under Section 5 of the said Act and advising the State Government generally in the matter of fixing and revising the minimum rates of wages under the said Act, namely :—
