## A W A R D

2. This is an application under Section 2 A(2) of the Industrial Disputes Act, 1947 filed by the second party workman challenging his termination of service with effect from the 9th January 1991 by the first party management.

3. This case is posted to today for hearing. Neither the second party workman is present nor it has taken any steps. The authorized representative of the first party management is present.

4. The record reveals that after filing of the case u/s. 2 A (2) of the Industrial Disputes Act, the second party workman has not entered its appearance till today. The Regd. Notice sent to it returned undelivered with the postal remark “no such addressee in the place”. After filing written statement by the management issues have already been settled in this proceeding and the matter is posted to today for hearing. But, in absence of any evidence on record substantiating the claim, it is not possible to adjudicate the issues involved in the case, simply basing on the statement of claim and written statement which are self serving documents. Accordingly, a No Dispute Award is passed is so far the present claim is concerned.
