S.R.O. No. 367/2014—Whereas, the draft Notification for the purpose of inclusion of additional 58 (fifty-eight) Revenue Villages in the "Kalinga Nagar Development Area" declared as such in the Notification of the Government of Odisha in the Housing & Urban Development Department No. 33044/HUD., dated the 28th July 1992 was published as required by Rule 3(1) of the Odisha Development Authorities Rules, 1983 in the extraordinary issue of the *Odisha Gazette* No. 956, dated the 20th May 2013 under the Notification of the Government in the Housing & Urban Development Department No. 16055/HUD., dated the 6th May 2013;

And whereas, the objections and suggestions and views as received in respect of the said draft before the expiry on the date specified by the State Government in the said Notification are duly considered;

Now, therefore, in the exercise of powers conferred by sub-section (2) of Section 3 of the Odisha Development Authorities Act, 1982 and in partial modification to the Government of Odisha in the Housing & Urban Development Department Notification No. 33044/HUD., dated the 28th July 1992, the State Government do hereby declare that the existing Kalinga Nagar Development Area shall include the additional areas of the Revenue Villages as mentioned in Column (2) of Schedule-I below and accordingly the boundaries of Kalinga Nagar Development Area shall be declared in Schedule-II below:
