AWARD

The Government of Odisha in the Labour & Employment Department in exercise of the powers conferred under sub-section (5) of Section 12 read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, have referred the following dispute vide Order No. 9025-li/1(SS)-8/2005/ L. E., dated the 27th October 2005 for adjudication:

"Whether the action of the management of M/s L. & T. Ltd., Kansbahal in terminating the services of Shri Mourice Minz No. P. & IR/LAB/TER/2320, dated the 30th March 1994 is legal and /or justified? If not, to what relief Shri Minz is entitled?"

2. Today both parties are found absent on calls. So it can be presumed that either they have settled their dispute amicably outside the Court in the mean time or they have no dispute between them. Hence no dispute award is passed.
