The Government of Odisha in Labour & Employment Department in exercise of their powers conferred under sub-section (5) of Section 12 read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act have referred the following dispute Vide Order No. 2751—li/1(SS)-22/06-L.E., dated the 23rd March 2007 for adjudication :—

"Whether the action of the management of SAIL, Rourkela Steel Plant, Rourkela in promoting Shri Lalit Suna and Rajkishore Mohanty to the post of Ward Master-*cum*-Operator vide Order dated the 18th July 2003 ignoring the case of Shri S. Kumar is justified and/or legal ? If not, what relief Shri Kumar is entitled to ?"

2. Today both parties are found absent on calls. So it can be presumed that either they have settled their dispute amicably outside the Court in the mean time or they have no dispute between them. Hence No Dispute Award is passed.
