AWARD

The Government of Odisha in Labour & Employment Department in exercise of their powers conferred under sub-section (5) of Section 12 read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act have referred the following dispute Vide Order No. 3017— li/1(SS)-09/03/L.E., dated the 26th March 2003 for adjudication :—

"Whether denying promotional benefits to Shri R. Mohanty, PI. No. 38278, A. Alli, PI. No. 38279, R. N. Mallick, PI. No. 38283, D. Naik, PI. No. 38284, N. C. Sahu, PI. No. 38288, P. Naik, PI. No. 38287, B. Dandia,(S.C.), PI. No.38289, and K. K. Mohanty, PI. No. 38322 of SWPP department by the management of Rourkela Steel Plant, Rourkela as per the principles under which the 14 number of employees were granted promotional benefits to S-9 grade vide Order No. PI. HRM/03, dated the 2nd January 2001 is legal and/or justified ? If not, what relief the above named employees are entitled to?"

2. On notices being sent the representative of the management remained present whereas the representative of the workmen filed a petition stating that they do not want to proceed with case. So, it seems that either there is no dispute or they have settled their dispute amicably outside the court. Accordingly No Dispute Award is passed.
