AWARD

The Government of Odisha in Labour & Employment Department in exercise of their powers conferred under sub-section (5) of Section 12 read with clause (d) of Sub-section (1) of Section 10 of the Industrial Disputes Act have referred the following dispute vide order No. 11569—IR(ID)-158/2012-L.E., dated the 23rd September 2013 for adjudication :—

"Whether the demand of Kansbahal Industrial Labour Association for payment of 20% Bonus and 50% *Ex Gratia* to the contract workers working under 1. M/s Anupam Ray , 2. M/s M.M. Chhotray 3. M/s Purna Security Service, 4. M/s Anu Engineering Works, 5. M/s Techno Fab Mfg. Ltd. 6. M/s Renuka Electricals, 7. Chhaterjee Engg. 8. M/s Aries Wind Tech., (P) Ltd., 9. Odisha Engineers (P) Ltd., 10. M/s Mishra Enterprises, 11. M/s Zigma Electronics, 12. M/s Jaymar, 13. M/s Iswar Engg. Works 14. M/s Maa Laxmi Construction, Contractor establishments in M/s L&T Ltd., Kansbhal, Dist. Sundargarh for the A/c year 2005-2006 is legal and/or justified ? If so, what relief the contract workers are entitled to ?"

2. On notices being sent both parties neither appeared nor sent any information. From this, it can be presumed that either they have settled their dispute outside the Court or they have no interest to conduct the case. Hence no dispute Award is passed.
