NOTIFICATION

The 21st November, 2014

S.R.O. No. 522/2014— Whereas, in the notification of the Government of Odisha in the Housing & Urban Development Department No. 32943/HUD., dated the 15th November, 2013 published in the Extraordinary issue of the *Odisha Gazette* No.2221, dated the 16th November, 2013 the area comprising of the areas with the boundaries thereof in the district of Sambalpur mentioned in the schedule to that notification have been proposed to be specified as “larger urban area” inviting objections and suggestions from all persons likely to be affected thereby;

And, whereas, the objections and suggestions received for the said proposed larger urban area have been duly considered by the State Government;

Now, therefore, in exercise of the powers conferred by clause (2) of Article 243Q of the Constitution of India read with sub-section (1) of Section 3 of the Odisha Municipal Corporation Act, 2003 (Odisha Act 11 of 2003) the Governor of Odisha do hereby specify the area comprising of the areas mentioned in the schedule below in the district of Sambalpur with boundaries thereof as a larger urban area.
