NOTIFICATION

The 22nd November, 2014

S.R.O. No. 528/2014— Whereas, the notification showing reservation of offices of Chairperson of the Municipalities of the State for Scheduled Castes, Scheduled Tribes, Backward Class of citizens and women was published as required by sub-rule (5) of rule 67 of the Odisha Municipal (delimitation of Ward, Reservation of Seats and Conduct of Election) Rules, 1994 in the Extraordinary issue No. 1617 of *Odisha Gazette*, dated the 24th October, 2014 under the notification of the Government of Odisha in the Housing & Urban Development Department No. 21210, dated the 24th October, 2014 bearing S.R.O. No. 486/2014 inviting objections/suggestions from all persons affected thereby till the expiry of a period of fifteen days from the date of publication of the said notification in the *Odisha Gazette*;

And, whereas, the objections and suggestions received for the said draft on or before the date so specified have been duly considered by the State Government;

And, whereas, the reservation of the offices of the Chairperson of 9 Municipalities were worked out basing on the provisions of Article 243T of the Constitution of India read with sub-section(4) of Section 47 of the Odisha Municipal Act, 1950;

Now, therefore, in pursuance of sub-section (4) of Section 47 of the Odisha Municipal Act, 1950 (Odisha Act 23 of 1950) read with sub-rule (6) of rule 67 of the said rules, the State Government do hereby reserve the offices of Chairpersons for the categories as mentioned in column (3) of the Schedule given below against each of the Municipalities mentioned under column (2) thereof.
