### NOTIFICATION

The 15th February, 2014

**S.R.O. No.50/2014**— The State Government hereby publish the draft notification appended hereunder as required under the proviso under section (2) of Section 4 of Odisha Municipal Act, 1950 inviting objections and suggestions from all persons likely to be affected thereby and notice is hereby given that the said draft notification shall be taken into consideration on or after expiry of the period of thirty days from the date of publication of the same in the *Odisha Gazette*.

Any objection and suggestion in respect of the said draft notification may be submitted through the Collector & District Magistrate, Kalahandi within thirty days from the date of the publication of this notification in the *Odisha Gazette*. Objections and suggestions as may be received before expiry the said period shall be duly considered by the State Government.

### DRAFT

In exercise of the powers conferred by clause (2) of Article 243(Q) of Constitution of India read with sub-section (2) of Section 4 of the Odisha Municipal Act, 1950(Odisha Act 23 of 1950), the Governor of Odisha having regard to the population of the area consisting of the revenue villages in the District of Kalahandi mentioned in column (2) of the Scheduled below, the density of population, the revenue generated for local administration, the percentage of employment in non-agricultural activities therein and the economic importance of the said area, do hereby specify the said area as 'transitional area' with effect from the date of publication of this notification in the *Odisha Gazette*.
