AWARD

The Government of Odisha in Labour & Employment Department in exercise of their power conferred under sub-section(5) of Section 122 read with Clause (d) sub-section (1) of Section (10) of the Industrial Disputes Act have referred the following dispute vide order No. 2621-li/1(S)24/06/L.E. dated the 20th March 2007 for adjudication :

"Whether the demand of the employees of Jharsuguda Cement Works of M/s Ultra Tech Cement Ltd, Dhutra, Post Arda, Dist Jharsuguda putforth by the Jharsuguda Cement Workers Karmachari Snagha for payment of bonus/production linked bonus for the accounting year 2005-06 @ Rs. 10,000 per employee is legal and/or justified ? If so, what what should be the quantum of the details ?"

2. On notices being sent, the management appeared and thereafter remained absent in spite of several notices issued to them. But the 2nd party remained absent in spite of several notices to him. So it seems that either there is no dispute or they have settled their dispute amicably outside the court. Accordingly, no dispute award, is passed
