## AWARD

The Government of Odisha in Labour & Employment Department in exercise of their power conferred under sub-section (5) of Section 12, read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act have referred the following dispute vide Order No. 7641—li/1 (SS)-4/2007-L.E., dated the 11th June 2007 for adjudication.

“Whether the action of the management of M/s East India Steel (P) Ltd., Industrial Area, Rourkela in refusing employment to Shri Niranjana Samantray, Supervisor with effect from the 16th February 2007 is legal and/or justified ? If not, what relief Shri Samantray is entitled to ?”

2. The case is fixed today for appearances of the parties, but today neither of the parties appeared before this Tribunal nor sent any information. Hence, it can be presumed that at present there is no dispute between them or they have settled the dispute outside the Court in the meantime. Accordingly no dispute award is passed.
