AWARD

The Government of Odisha in Labour & Employment Department in exercise of their power conferred under sub-section (5) of Section 12 read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act have referred the following dispute vide Order No. 2618—li/1 (SS)-8/2003-LE., dated the 15th March 2003 for adjudication :—

“Whether the termination of services of Smt. Suprava Behera, Jr. Assistant with effect from the 17th July 2002 by the Management of Urban Co-operative Bank Ltd., Rourkela is legal and/or justified ? If not, what relief Smt. Behera is entitled to” ?

Today both parties appeared at Lok Adalat and filed a joint petition wherein it has been mentioned that they have settled the dispute amicably outside the Court as per the terms and conditions arrived between the parties and pray to pass award accordingly. Accordingly No Dispute Award is passed and the case is disposed of. The terms and conditions of settlement do form a part of the award.
