AWARD

The Government of Odisha in Labour & Employment Department in exercise of their powers conferred under sub-section (5) of Section 12 read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act have referred the following dispute vide Order No. 3983—li/1(SS)-7/2003-L.E., dated the 19th April 2003 for adjudication :

“Whether the terminated of services of Shri J. B. Tirkey, Junior Assistant, with effect from the 17th July 2002 by the management of Urban Co-operative Bank Ltd., Rourkela is legal and/or justified ? If not, to what relief Shri Tirkey is entitled ?”

Today both parties appeared at Lok Adalat and filed a joint petition wherein it has been mentioned that they have settled the dispute amicably outside the Court as per the terms and conditions arrived between the parties and pray to pass Award accordingly. Accordingly No Dispute Award is passed and the case is disposed of. The terms and conditions of settlement do form a part of the award.
