AWARD

The Government of Odisha in Labour & Employment Department in exercise of their power conferred under sub-section (5) of Section 12 read with Clause (d) sub-section (1) of Section 10 of the Industrial Disputes Act have referred the following dispute vide Order No. 1352—li/1(S)-7/2000-LE., dated the 13th February 2006 for adjudication :—

“Whether the demands of the workmen of M/s Orissa Industries Ltd., Lathikata for upward revision of existing attendance incentive conveyance allowance and dust allowance are justified ? If so, what should be the details ?”

2. On notices being sent, the management appeared and thereafter remained absent in spite of several notices issued to them. But the 2nd party remained absent inspite of several notices issued to him. So it seems that either there is no dispute or they have settled their dispute amicably outside the Court. Accordingly No Dispute Award is passed.
