AWARD

The Government of Odisha in Labour & Employment Department in exercise of their powers conferred under sub-section (5) of Section 12 read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act have referred the following dispute vide Order No. 170—li/1(B)-79/2006-LE., dated the 7th January 2008 for adjudication :—

“Whether the demand of the Union for implementation of surrender leave facility to Grade. VI-A employees at par with other employees of Bank is legal and/or justified ? If so, what should be the entitlement ?”.

2. On notices being sent, both parties remained absent in spite of several notices issued to them. From this it appears that either in the mean time they have settled their dispute amicably outside the Court or they have no dispute between them. Accordingly No Dispute Award is passed.
