AWARD

The Government of Odisha in Labour & Employment Department in exercise of their powers conferred under sub-section (5) of Section 12 read with Clause (d) sub-section (1) of Section 10 of the Industrial Disputes Act have referred the following dispute vide Order No. 3958—li/1(J)-40/2006-LE., dated the 29th March 2008 for adjudication :—

“Whether the demand of Koraput Central Co-operative Bank Employees Association for grant of Surrender leave and L. T. C. benefits to the employees of Koraput Central Co-operative Bank Ltd. is genuine and/or justified ? If so, what should be the details ?”.

Today both parties appeared at Lok Adalat and filed a joint petition wherein it has been mentioned that they have settled the dispute amicably outside the Court as per the terms and conditions arrived between the parties and pray to pass award accordingly. Accordingly No Dispute Award is passed and the case is disposed of. The terms and conditions of settlement do form a part of the award.
