The Government of Odisha in Labour & Employment Department in exercise of their power conferred under sub-section (5) of Section 12 read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act have referred the following dispute vide Oder No. 1362—li/1(S)-7/2000-L.E. dated the 13th February 2006 for adjudication :—

“Whether the demand of the workers of M/s Orissa Industries Ltd., Lathikata for improvement of existing medical facility is legal and/or justified ? If so, what should be the details ?”

2. On notices being sent, both parties remained absent and neither they appeared nor sent any intimation. From this, it can be presumed that either they have settled their dispute amicably outside the Court or they have No dispute between them. Accordingly No Dispute Award is passed.
