No. 2823—Elec. (GP)-21/2014-SEC.—Whereas, the tenure of Dhinkia Gram Panchayat under Ersama Block in the Jagatsinghpur District expired on the 13th May 2014 ;

Whereas, the Elections to Dhinkia G. P. could not be held in time before the expiration of the tenure due to ensuring General Election to Assembly and Parliament in the State ;

Whereas, the State Election Commission, Odisha has already prepared the Electoral Roll for the aforesaid G. P. for holding election in the said G. P. ;
