## AWARD

The Government of Odisha in Labour & Employment Department in exercise of their powers conferred under sub-section (5) of Section 12, read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act have referred the following dispute vide Order No. 13869—li/1(SS)-31/2005-L.E., dated the 20th December 2007 for adjudication :—

“Whether the workmen of Electrical Section of Iron and Steel Zone are entitled to get the same benefits as extended to the workmen of Rolling Mills (Electrical Zone) as per the settlement dated the 7th May 2001. If not, what relief they are entitled to ?”

2. Today both parties are found absent on calls. So it can be presumed that either they have settled their dispute amicably outside the Court in the meantime or they have no dispute between them. Hence, No Dispute Award is passed.
