## AWARD

The Government of Odisha in Labour & Employment Department in exercise of their power conferred under sub-section (5) of Section 12, read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act have referred the following dispute vide Order No. 5061—li/1 (SS)-8/2007-LE., dated the 29th April 2008 for adjudication :—

“Whether the House Rent Allowance @ 15% of revised basics of the workers who have not been provided with companies quarter with effect from the 1st October 2001 so demanded by the Union is legal and/or justified ? If not, what should be the details ?”

2. On notices being sent both parties remained absent on calls in spite of receiving the notices issued from this Tribunal. So it seems that either there is no dispute or they have settled their dispute amicably outside the Court. Accordingly, No Dispute Award is passed.
