Subject: Constitution of Inter-Departmental Task Force at City Level for implementation of projects under Smart City Mission.

After careful consideration, Government have been pleased to constitute an Inter-Departmental Task Force at City Level with the following members for implementation of projects under Smart City Mission to be executed with the financial support of Government of India.

- ii.* Collector of the concerned District/ Municipal
Commissioner of the City (Junior of the two) : Member
- iii.* Superintendent of Police/DCP of the City : Member
- iv.* Vice-Chairman of the Development Authority : Member
- v.* Divisional Forest Officer (D.F.O.) : Member
- vi.* Project Director, District Urban Development Agency : Member
- vii.* Executive Engineer (s), Public Health (Urban) : Member
- viii.* Executive Engineer (s), Public Works Department : Member
- ix.* Executive Engineer (s), Drainage of W.R. Department : Member
- x.* R.T.O.(s) of the concerned City : Member
- xi.* Representative of O.W.S.S.B. : Member
- xii.* Representative of B.S.N.L. : Member
- xiii.* Representative of CESU/ NESCO/SOUTHCO/WESCO : Member
- xiv.* CEO of the SPV for the Smart City : Member Convenor

2. Functions of the Inter-Departmental Task Force at City Level are as follows:
 - i.* Overall monitoring of the project at City level
 - ii.* Inter Departmental coordination among concerned city level organisation and resolving issues at City level.
 - iii.* Important & focal point for redressal of public grievances of local citizens. It shall hear the problems and grievances faced by public and different executive agencies and resolve them for smooth & faster implementation of mission programme.
3. The Task Force shall meet at least once in every quarter and more often if required to address the issues at City level for implementation of mission programme.
4. The Chairperson may invite any Officials of other Government/Non-Government organisation as Special Invitee in the interest of the mission programme.
5. The Task Force shall be serviced by Special Purpose Vehicle to be constituted for Smart City Programme.
6. The tenure of this Inter-Departmental Task Force is co-terminus with the Smart City Mission Programme.
7. It shall come in to force from the date of issue of this Notification.
