## STATE CO-OPERATIVE ELECTION COMMISSION, ODISHA

### NOTIFICATION

The 22nd August, 2015

**S.R.O. No. 369/15**— In continuation to this Commission Notification No. 1651/SCEC., Dated 05.08.2015 the officers as in Annexure are further appointed as Assistant Election Officers for the Odisha State Co-operative Union Ltd, Bhubaneswar in connection with conduct of election of this Society, fixed to be held on 11.10.2015 as per the Notification No.5673/Coop.Dtd.04.08.2015 of Govt. in Co-operation Department.

The appointment of Sri Kalyan Kumar Chatterjee, Inspector of C.S.,O/o the ARCS, Bhubaneswar Circle as Assistant Election Officer of Odisha State Co-operative Union Ltd. Bhubaneswar made vide the Commission Order No 1651 Dt. 05.08.2015 is cancelled.

As defined under Rule 2(d) of the OCS (Elections to the Committees) Rules, 1992 the Election Officers, includes Assistant Election Officer. Therefore, the Assistant Election Officers so appointed are to discharge all or any function of the Election Officer as per the Provisions of the OCS Act, 1962 and (Elections to the Committees) Rules, 1992 and to assist the Election Officer in conduct of the Election.

The Officers appointed are required to perform their duties as assigned to them for smooth conduct of election of Co-operative Societies and deviation in this regard in any manner would attract penal provision under sub-section 11 & 12 of Section 115 of OCS Act, 1962 and Rule-56 of OCS (Elections to the Committees) Rules, 1992.

This order will come into force forthwith and the same be published in the Extraordinary issue of *Odisha Gazette*.
