No.29240–HUD-13-PHE-38-HR-18-III-P-255/2015/HUD.—Consequent upon restructuring of the cadre of the Odisha Engineering Service vide Housing & Urban Development Department Resolution No.29433/HUD., dated the 28th September, 2013 and in conformity with Water Resources Department Notification No.5484/WR., dated the 26th February, 2014 and pursuant to the decision of the Cabinet in its 46th meeting held on 24th February, 2014, the Assistant Engineers (Civil) in PHE Cadre appointed on *ad hoc* basis and regularised through Orissa Service of Engineers (Validation of Appointment) Act, 2002 were upgraded to the rank of Assistant Executive Engineer in Junior Class-I Branch in Odisha Engineering Service, P.H. Cadre carrying scale of pay ₹ 15600-39100/- with Grade Pay ₹ 5400/- in PB-3 vide Housing & Urban Development Department Notification No.5417/HUD., dated the 26th February, 2014.

Shri Sarat Chandra Mishra, Assistant Engineer appointed on *ad hoc* basis and regularised through Orissa Service of Engineers (Validation of Appointment) Act, 2002 and who has been allowed to continue as Assistant Engineer, P.H. pursuant to Housing & Urban Development Department Order No.10954/HUD., dated the 22nd April, 2015 is upgraded notionally with effect from 22nd April, 2015 (A.N.) to the rank of Assistant Executive Engineer in Junior Class-I Branch in O.E.S., P.H. Cadre carrying scale of pay ₹ 15600-39100/- with Grade Pay ₹ 5400/- in PB-3.

Upon up-gradation to the rank of Assistant Executive Engineer Shri Mishra is allowed to continue as Assistant Executive Engineer in the O/o E.I.C., P.H.

His pay in the rank of Assistant Executive Engineer shall be notionally fixed with effect from 22nd April, 2015 (A.N.) and actual financial benefit shall be allowed to him from the date he joins as Assistant Executive Engineer, P.H.

His *inter-se-position* in the gradation list of Assistant Executive Engineer, P.H. issued vide Housing & Urban Development Department Office Order No.13122/HUD., dated the 28th June, 2014 is fixed below Shri Anup Kumar Mishra at Serial No.62 and above Shri Bibhu Prasad Panda at Serial No.63 as per his position in the O.S.E. (Validation of Appointment) Act, 2002 and judgement dated the 19th February, 2014 of Hon'ble Supreme Court of India passed in C.A No.8322/2009 and batch cases.
