No. 6136—EL(GP)-01/2014(Pt.)-SEC.—Whereas, the Sub-Collector, Baliguda-cum-Election Officer, 9-Tumudibandha Zilla Parishad Constituency in Kandhamal District has deviated on the 23rd December 2014 from the election schedule issued by the Commission vide Notification No. 5661-SEC., dated the 8th December 2014 for election to 9-Tumudibandha Zilla Parishad Constituency as revealed from the report of the Collector and District Magistrate, Kandhamal vide his Letter No. 999, dated the 29th December 2014.

Now, therefore, in exercise of the powers conferred under Article 243-K of the Constitution of India and Rule 59 of Odisha Zilla Parishad Election Rules, 1994, the State Election Commission hereby cancels the aforesaid election schedule from the 23rd December 2014 after scrutiny of nomination papers and onwards.
