(C) No.23468-Mohammad Moquim-Vrs.-JICA & Others under intimation to Government in H & U.D. Department.

4.The Chairperson may co-opt any other officials/non-officials as Member or Special Invitee in the interest of JICA assisted OISIP.

5. The Committee shall be serviced by the Odisha Integrated Sanitation Improvement Project.

6. It shall be come in to force from the date of issue of this Notification.
