ORDER

No. 1840—SEC.—Whereas, Executive Officer of Padampur N.A.C. and Buguda N.A.C. have reported about occurrence of casual vacancy in the office of Councillor of Ward No. 2 Padampur N.A.C. and Ward No. 13 of Buguda N.A.C. vide their Letter NOs, 1833, dated the 17th December 2014 and 1954 dated the 16th December 2014, respectively;
